Re: Official Information Act (1982) request – Number of Māori providers and criteria for an organisation to be considered as a Māori provider

I write in response to your Official Information Act request, which we received on 19 September 2018. The request was a partial transfer from the Ministry of Health, under section 14 of the Act. The Ministry of Health advised all DHBs that you had requested the following information, which they believed DHBs were best placed to provide a response to:

- (i) What criteria is used by the MoH and District Health Boards (DHBs) to determine if an organisation meets criteria to be considered (and funded as) a Māori provider?
- (ii) How many Māori providers funded by MoH and/or DHBs are there nationally? Please provide a list of these.

For the Auckland and Waitemata DHB (ADHB/WDHB) catchments, we advise the following response:

We apply the Ministry of Health (MoH) criteria for the Māori Provider Development Scheme (MPDS) to define a Māori provider. Further information on the scheme and those Māori Health providers who receive funding under the scheme is described on the MoH webpage: https://www.health.govt.nz/our-work/populations/maori-health/maori-health-providers

The definition for the MPDS is:

"Funding under the MPDS for regional Māori health and disability providers is only available to health providers or health organisations that are owned or operated by iwi, and or Māori organisations".

In order to be eligible for MPDS funding, the Ministry of Health states applicants must be either:

- an existing Māori health provider or Māori organisation which has contracts with the Ministry of Health and/or District Health Board.
- an existing Māori health provider or Māori organisation that is in the process of negotiating a contract with the Ministry of Health and/or District Health Board; or
- part of a joint venture with a Māori health provider.
