Re: Official Information Act request – Auckland Regional Dental Service vacancies

Thank you for your Official Information Act request of 1 July 2019 seeking the following of Waitematā District Health Board (DHB):

The FTE and headcount numbers of dental therapists/oral health therapists, dental assistants and patient care assistants employed by Auckland Regional Dental Service (ARDS), divided by team.

The current vacancies (FTE) each ARDS team currently has.

The Auckland Regional Dental Service (ARDS) provides oral health and dental services to approximately 273,000 preschool and school-aged children, up to and including school year eight students, living in the Auckland metropolitan area. The service is managed by Waitematā DHB on behalf of the three Auckland metropolitan DHBs (that is, Auckland DHB, Counties Manukau Health and Waitematā DHB).

Recent analysis undertaken indicates that there are a number of reasons staff are choosing to leave the service. The primary reasons include retirement, moving out of Auckland and moving to work in private practice. In order to address this, the service is:

- Implementing additional supports for new and recent graduates.
- Identifying opportunities to develop new roles and introduce new models of care.
- Partnering with staff to offer more flexibility in location and hours of work.
- Identifying strategies to enable dual trained (dental therapy and hygiene) therapists to maintain competency across both scopes of practice.
- Encouraging dental assistants/patient care assistants to participate in Career Force training.

I trust that this information meets your requirements. Waitematā DHB, like other agencies across the state sector, supports the open disclosure of information to assist the public's understanding of how we are delivering publicly-funded healthcare.

This includes the proactive publication of anonymised Official Information Act responses on our website from 10 working days after they have been released.

If you feel that there are good reasons why your response should not be made publicly available, we will be happy to consider this.
