**Re: OIA request – Copies of documents related to Oranga Tamariki**

Thank you for your Official Information Act request to Waitematā District Health Board (DHB) on 9 July seeking information requesting copies of documents related to Oranga Tamariki.

Before responding to your specific questions, it may be useful to provide some context about our services.

Waitematā DHB serves a population of more than 630,000 across the North Shore, Waitakere and Rodney areas, the largest and one of the most rapidly growing DHBs in the country. We are the largest employer in the district, employing around 7,500 people across more than 80 locations.

In addition to providing services to our own population, we are also the metropolitan Auckland provider of forensic psychiatry, child disability services, child community dental services and community alcohol and drug services.

In response to your request, we are able to provide the following information:

**With respect, I request the following information under the terms of the Official Information Act 1982: A copy of any letters, emails, telephone call logs or meeting notes sent or received by staff on 12 June 2020, relating to Oranga Tamariki removals of children, sometimes euphemistically and incorrectly referred to as 'uplifts', from Waitakere Hospital.**

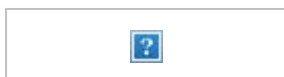

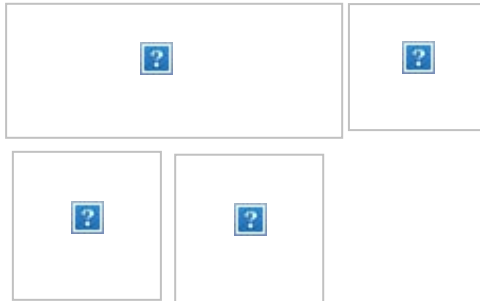

**Please attribute to Glynis Sandland, Deputy Chief Executive Services for Children and Families North**

There has been no attempt to take the baby away from the mum.

Oranga Tamariki had no intention to remove this baby and we are continuing to explore the best options for mother and child.

Oranga Tamariki and its predecessors have been working with the mum for a number of years.

During the pregnancy, we worked alongside her and the wider family to address serious safety concerns for the baby.

The Chief Executive was granted interim custody under Section 78 to ensure the safety of her baby. Under this order, the baby can be placed in the care of any person and not necessarily taken away from the mother, where there is appropriate support for both mother and baby.

We are continuing to work through a number of options with the parents and their wider whanau and our shared goal is to find a way to keep mother and baby together and safe.

We have also offered to help the mother with food, baby clothes and any other support she needs.

A meeting is planned next week with iwi and community providers to discuss how we can work together, with mum and family being critical to decision making.

**Other baby at Waitakere Hospital**

There is no Section 78 order in place for the other baby at Waitakere Hospital.

Claims that Oranga Tamariki attempted to bring baby into its care without notice are incorrect.

Social workers have been working with the mother and will continue to do so to address care and

protection concerns.

## **DHB**

We do not have a formal agreement with the Waitemata District Health Board (WDHB) which prevents us from taking babies into our care.

We do however have an agreement to work together early and put a plan in place which involves the mother, wider family, midwife, hospital social worker, social services and iwi.

We work with the DHB and other agencies to keep families together, wherever possible.

## **Waipareira Trust**

If a family or mum approaches us through the Waipareira Trust we will be happy to work with them in the best interests of the child concerned.

We have an agreement in place with the Trust for services for families with vulnerable children.

### **Waitematā DHB position on the protection of newborn babies**

Waitematā District Health Board (DHB) recognises the critical importance of child protection and works cooperatively with agencies such as Oranga Tamariki to ensure the safety of children.

In situations where babies are born in our hospital facilities and Oranga Tamariki has significant concerns, our approach is to bring the mother and whānau together with Oranga Tamariki to seek an agreed and mediated solution that is satisfactory to all parties.

The DHB is respectful of the law at all times. We do believe, however, that our hospitals are places of caring and compassion and that the potential separation of babies in the newborn maternity environment in the absence of an agreement by whānau has a potentially damaging impact, not just on those directly involved but also on the wider hospital community - including staff and other users of our maternity services.

Whenever it is possible and within the law, we therefore seek to try and avoid such activity within our newborn maternity environment.

We understand the underlying complexities behind decisions of this nature and believe a mediated approach to finding agreeable solutions is the best possible outcome that we should strive for, no matter how difficult this might be.

Waitematā DHB will always be available to assist with mediation as we have access to extensive networks in our community who are willing to assist.

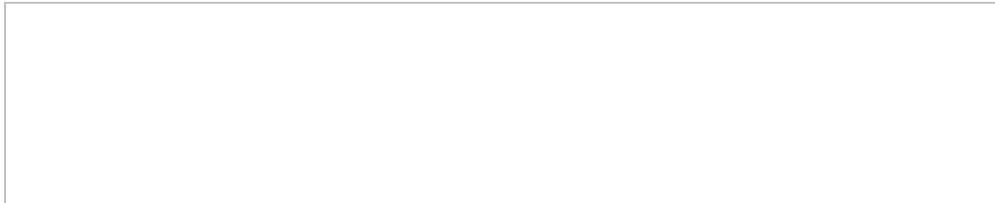

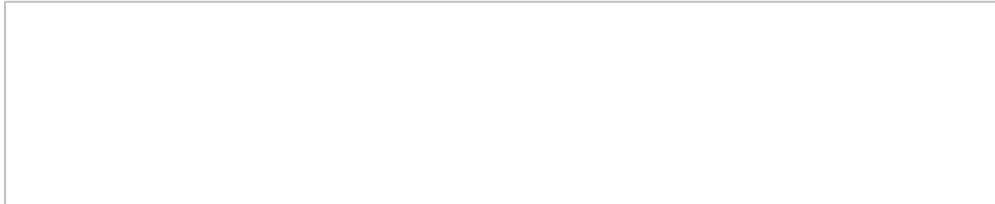

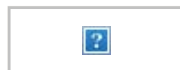
